The legal voters of the Barstow Unified Union School District (Unified Union District) comprising the voters of the Town of Chittenden and the Town of Mendon are hereby notified and warned to meet at the Barstow Memorial School, on February 27, 2018, in the hall of said school, at 6:30 p.m. to conduct the following business:

- <u>Article 1:</u> To elect the following officers to serve from their election and qualification until the next Annual District Meeting of 2019 following the election and qualification of their successors:
 - 1. Moderator
 - 2. Clerk
 - 3. Treasurer
- Article 2: To have presented by the Board of School Directors of the Barstow Unified Union School District its estimate of expenses for the ensuing year.
- <u>Article 3:</u> To determine and approve compensation, if any, to be paid Unified Union District Officers.
- Article 4: To authorize the Unified Union District to borrow money pending receipt of payments from the State Education Fund or Town Tax Funds by the issuance of its notes or orders payable not later than one year from date: provided, however, that the Unified Union District is authorized by Vermont Statutes to borrow sufficient funds to meet pending obligations.
- Article 5: To transact any other school business thought proper when met.

The meeting shall then be recessed to Tuesday, March 6, 2018, for the purpose of voting the following articles at the usual polling place in the member district by Australian ballot, said ballots being brought to Chittenden Town Offices following the closing of the polls in the member districts where they will be commingled and counted by the Board of Civil Authority of the constituent districts.

Board Members Present: Kathleen Cunningham, Deborah Singiser, Erica McLaughlin, and Michelle Erickson

Others Present: Jeanné Collins, RNESU Superintendent; Brenda Fleming, RNESU Director of Business and Finance; Renée Castillo, Barstow Principal; Bob Baird, Moderator; Sara Tully, BUUSD Board Treasurer; Kathy Hall, BUUSD Clerk; Ann Singiser, Mendon JP; Townspeople

Call to Order: The meeting was called to order at 6:34 p.m. by Bob Baird. Bob introduced RNESU Superintendent Jeanné Collins, Business Manager Brenda Fleming, Clerk Kathy Hall, Treasurer Sara Tully and Principal Renée Castillo. He then turned the meeting over to Jeanné Collins to conduct election of Moderator.

<u>Article 1</u>: To elect the following officers to serve from their election and qualification until March 2018 following the election and qualification of their successors:

- 1. Moderator
- 2. Clerk
- 3. Treasurer

Jeanné Collins accepted a friendly amendment of Article 1 offered by Ann Singiser:

<u>Article 1</u>: To elect the following officers to serve from July 1, 2017 (after their election and qualification) until March 2018 following the election and qualification of their successors:

- 1. Moderator
- 2. Clerk
- 3. Treasurer

A motion was made by Deborah Singiser, seconded by Sara Tully to nominate Bob Baird as *Moderator*. Elected by acclamation. Jeanné Collins then administered the oaths to Bob Baird and turned the meeting over to Bob Baird.

A motion was made by Sara Tully, seconded by Meredith Voutas to nominate Kathy Hall as Clerk. Elected by acclamation. Jeanné Collins then administered the oaths to Kathy Hall.

A motion was made by Amy Merrill, seconded by Michael Tully to nominate Sara Tully as *Treasurer*. Elected by acclamation. Jeanné Collins then administered the oaths to Sara Tully.

<u>Article 2</u>: To have presented by the Board of School Directors of the Barstow Unified Union School District its estimate of expenses for the ensuing year.

Michelle Erickson introduced the members of the Board, and they presented the Barstow Budget Summary FY18 (see 2017 BUUSD Annual Report). Questions and clarifications were addressed.

□ "All Mendon and Chittenden students" refers to all PreK to 12 students in both towns.

- □ Nancy Boynton asked for the cost of renovations on the Barstow House. Brenda Fleming explained the \$25,000 in renovations include asbestos removal, new windows, etc. The new head custodian contract includes use of the house and is reflected in less salary.
- □ Mary Lou Bolt, a neighbor of the school, expressed appreciation for the house improvements.
- □ Georgie Grover asked if any budget money will be available for renovation of the playground. Brenda Fleming explained that it is not in this budget, but a reserve fund for projects like the playground may be used.
- □ Georgie Grover congratulated the Board for keeping the budget increase so low.
- □ Kellie Becker asked if the Board has ever considered contracting out transportation services. Brenda Fleming said that alternative has been studied, and it does not necessarily result in lower costs.
- □ Lisa Purcell asked what the plan is for the staff reductions in the budget. Jeanné Collins explained that a retiring teacher will not be replaced, the PreK position will be reduced to half time, and RIF of a part time science position is being considered. Principal Renée Castillo also explained possible junior high staffing models.
- □ Amy Merrill asked how much money is saved by not replacing a retiring teacher, and what is that tax impact. Brenda Fleming explained that salary and benefits for a new hire can range from \$60,000 to \$110,000, and that approx. \$30,000 equals a change in tax impact of about \$.01. Amy Merrill then asked if moving a teacher to a new assignment might require professional development costs to prepare that teacher for a new assignment. Jeanné Collins explained that while significantly changing grade levels can cause a need for PD, moving a teacher to a significantly new assignment is not in the plan.
- □ Jim Harrison appreciated the explanation of "ghost students," used in budget stabilization.
- Roland Smith, Jr. asked why the playground was shut down just as school started. Principal Renée Castillo explained that in the course of touring the property with the new head custodian rotting and instability was detected and a full inspection resulted in closing the structure. A playground committee at work has raised \$8000, GE is offering help, and grants and contests are being pursued.
- □ Georgie Grover asked what the new teacher assignments would be, and Renée Castillo said that those have not been decided.
- □ Kellie Becker asked if we qualify for state funding for pre-school. Jeanné Collins said we do not.

<u>Article 3</u>: To determine and approve compensation, if any, to be paid Unified Union District officers.

A motion by Nancy Boynton and seconded by Michael Tully to pay the Moderator and Clerk \$150 per meeting, the Treasurer \$2000 for the year, and the Board members \$750 for the year. Liz Stahura agreed with the increased compensations that Nancy moved.

Motion passed.

<u>Article 4</u>: To see if the voters will authorize establishment of a reserve fund to assist in funding the costs of capital repairs and improvements to the school facility and grounds with the Board of School Directors being authorized to expend monies in the fund without further voter approval.

This article was moved by Sara Tully, seconded by Michael Tully. Jim Harrison and Kellie Becker asked for clarification. Jeanné Collins and Brenda Fleming explained that tonight we are asked to authorize the creation of a reserve fund, not to put money into it. There is a reserve fund already in existence, for the former Barstow, but the newly formed Board must establish it in its own right as a new organization. The money from the old reserve fund was restricted for use on facilities only. This article allows the Board to add to it and the use it in the future. Motion passed.

<u>Article 5</u>: To see if the voters will authorize the Board of School Directors to deposit in the reserve fund established for the capital repairs and improvements of the school facility and grounds any surplus, or such portion of surplus funds, as the board deems appropriate, existing at the end of any fiscal year.

Moved by Amy Merrill and seconded by Georgie Grover.

• Roland Smith, Jr. asked for clarification of what the Board's options are. Brenda Fleming explained that money remaining in the operating budget can be put into the reserve fund, or could be returned to taxpayers, though money "given back" goes to the state, not to the two towns.

• Lisa Purcell asked what sort of uses the reserve fund could go to, and Erica McLaughlin explained that it would be used for large expenses, such as roofing or playground construction.

• Michael Kinsler asked if money could be allocated now for the playground. Brenda Fleming explained that a five-year operating plan is being compiled, which will analyze needs for 1-3-5 years out.

• Kellie Becker asked confirmation that the reserve fund is for Barstow UU, not for RNESU. Erica McLaughlin confirmed.

Motion passed.

<u>Article 6</u>: To authorize the Unified Union District to borrow money pending receipt of payments from the State Education Fund or Town Tax funds by the issuance of its notes or orders payable not later than one year from date: provided, however, that the newly formed Unified Union District is authorized by Vermont Statutes to borrow sufficient funds to meet pending obligations.

Moved by Amy Merrill, seconded by Michael Tully. Motion passed.

<u>Article 7</u>: To authorize the Board of School Directors to notify the electorate of the availability of future annual reports on-line, at Barstow school, Chittenden and Mendon town offices, or by request in lieu of distributing paper reports.

Moved by Georgie Grover, seconded by Meredith Voutas.

Justin Lindholm requested that paper copies be available at meetings. Superintendent Jeanné Collins explained that paper copies would be available at the school and the Town

Clerks' offices and can be mailed to anyone who requests it, but by not mailing to every voter, they can print half as many and save on postage and printing.

Lisa Purcell moved to amend the motion to include having paper copies at the BUUSD Annual Meeting. Seconded by Ann Singiser.

Amendment passed. Motion as amended passed.

Article 8: To transact any other school business thought proper when met.

• Michelle Erickson thanked all those who helped organize this meeting.

• Roland Smith, Jr. stated he was aware of an incident that took place at school last week. Jeanné Collins and Renée Castillo stated they were not aware of any incident and Ms. Collins asked him to meet with her and Principal Castillo immediately after the meeting.

• Lisa Purcell thanked the Board for the huge amount of work this past year making the transition to the new Barstow Unified Union School District.

• Deborah Singiser and the attendees thanked Michelle Erickson for her ten years of service to the school boards.

Bob Baird announced that this meeting will recess until voting on the following Articles:

<u>Article 10</u>: Shall the voters of the school district approve the school board to expend \$4,949,750 which is the amount the school board has determined to be necessary for the ensuing fiscal year? It is estimated that this proposed budget, if approved, will result in education spending of \$14,615 per equalized pupil. This projected spending per equalized pupil is 9.48 % higher than spending for the current year. However, member district homestead tax rates are anticipated to increase only 1.82% and 1.72% in Chittenden and Mendon respectively.

We have completed our first year of merger as the Barstow Unified Union School District. Barstow School continues to thrive and we welcomed several new families to our community this year.

We thank the residents of our fine towns for supporting the purchase and installment of a new playground after our old one was deemed no longer safe. The grounds of Barstow are for community use and this playground adds to that use for our families of young children.

Test scores at Barstow continue to be above the average state scores. Our student population is changing a bit and we added some supports this year to ensure all students succeed, such as an academic interventionist for extra literacy and math support and a school psychologist for social/emotional support. Principal Castillo is focused on helping teachers use data to determine student needs and has been highlighted in a national publication for her work on the use of Let's Talk, our communication portal, with students to increase reports of bullying and harassment.

This year RNESU says farewell and thank you to Kay Pelletier, Administrative Support for Special Education and Medicaid Clerk. Kay has been a mainstay for families and services for 25 years and we thank her for her service. Beth Ripley, currently of OVUHS, will replace Kay as of July, 2018.

While enrollment continues to be in a slow decline, we continue to be invested in the success of each student and to providing a safe, nurturing environment for learning. We have rolled out a new website and hope this will make information easier to gather. Please take a look and click on Let's Talk to communicate your thoughts and suggestions with us.

Rutland Northeast Supervisory Union Board of Directors' Annual Report

As continues to be the case, this year has been a challenging budget year. We worked hard to produce a fair and comprehensive budget, holding costs down as much as possible. You, the voters, saw that work and passed the budget last March, for which we are grateful. Then, before the Legislature recessed in the spring, they voted to take more money from the education fund to pay the state's other expenses, underfunding OVUU and BUU. In addition, we were told that in order to keep the education fund solvent, taxes need to cover an anticipated 39 million dollars Governor Scott moved to the general fund. All this means that we had to find a way to cover this year's "state imposed budget shortfall", find our portion of the 39 million and absorb the planned 2 cent reduction in merger incentive. This would mean reducing the budget by about \$1,600,000 before we even looked at the needs of our students, staff, and buildings.

We were in contract negotiations with the paraprofessionals and bus drivers again this year and also with the teachers. We tried to be fair and equitable knowing that the taxpayers had limits that had been perhaps already approached. Fortunately, we were able to reach settlements for both. In each contract, both sides compromised.

We continue to struggle with declining enrollment and smaller class size numbers. Our goal continues to be to provide the very best quality of education that our young people need and deserve. We have required our superintendent, Jeanné Collins, to bring in a budget that does more with less. We have publicly discussed plans of reconfiguration of grades, eliminating positions, combining classes, repurposing buildings, and cutting costs in all of our facilities. We held two public forums and many open board meetings. We know that change causes angst. But change must happen if we are to continue to provide affordable quality education for all of our district's students.

Our ultimate goal is to provide the very best quality education for all students. We know that the communities and the students count on our board to guarantee high standards, quality education, multiple opportunities to learn, a high degree of safety, and highly qualified teachers and staff to educate our children and get them ready to be outstanding citizens. We work hard to achieve those goals.

We thank you for the confidence you place in us and the great opportunity you give us to serve all of our children. It is our hope that you will see that the budget we present to you will meet all the needs of our students at a cost we can afford.

Dear Neighbors,

The Barstow Unified Union (BUU) Board of Directors is pleased to report that Barstow continues to provide the children in our towns with an outstanding education that prepares them for the next stage of their academic lives at an affordable cost. The BUU District is effectively working with the Otter Valley Unified Union and Rutland Northeast Supervisory Union (RNESU) boards to capitalize on our shared resources and expertise to ensure that every student in the RNESU has access to what they need to succeed. The BUU District continues to attract and maintain highly skilled and dedicated teachers and support staff who educate, inspire and support students in our school every day. We would like to express our gratitude to you, residents of Chittenden and Mendon, for your continued support of our outstanding school.

The BUU District's goal is to provide a high-quality education to our PK-8 students that justifies the resources invested by the community. We have learned through regular professional development that one of the board's key roles is to ensure there is a clear vision and mission towards which the staff can work. During the last year, we collaborated with board peers across the RNESU to set that clear vision and mission. We gathered thoughts and insights from our staff and community members as well. Now, with an established shared vision and mission in hand, the board can more effectively monitor the BUU District's progress. Moreover, with the formal adoption of Policy Governance as the BUU Board's results-oriented approach to governance, there are more clearly delineated lines of responsibility, holding everyone in the district more accountable for the outcomes. Each year at the annual meeting we will be able to share updates on the BUU District's progress toward its vision and mission.

As a local school board, we are currently facing several challenges that are outside of our control. Like most school systems across Vermont, we continue to be adversely affected by declining enrollment along with an increase in student needs. An additional challenge this year is Act 85, the Health Care Recapture in which the state withheld more than \$50,000 of revenue from our FY18 budget; a budget that you, the voters, approved at the polls last March. In response to these fiscal challenges, the BUU District intentionally and thoughtfully found savings through staff reductions and/or reassignments while continuing to be responsive to student needs. As a result, we anticipate ending the fiscal year without a deficit, something that seemed impossible last summer after the passage of Act 85.

It is bittersweet to once again say farewell and thank you to educators at Barstow who will retire at the end of the current school year. The BUU Board would like to thank Ms. Sue Boyer (5th Grade Teacher), Ms. Sherry Stubbins (Speech-Language Pathologist), and Ms. Heidi Webster (Librarian). Thank you for your years of service to the students at Barstow Memorial School. We wish you health and happiness in your welldeserved retirement for many years to come. You will be missed.

In closing, the BUU Board is committed to a long-term vision of a high-quality education for every child in the district. With your ongoing support, you can be assured our school will continue to prepare our youngest citizens to pursue their dreams and become contributing members of society. We encourage you to visit the school or attend a board meeting to share your ideas or ask questions, and become a part of the investment we are making in our towns' most precious resources -- our children.

This information includes: whether the teacher has met the state requirements for the grade level(s) and subject area(s) they are teaching; whether the teacher is teaching under an emergency license; the college major and/or graduate certification or degrees held by the teacher; and whether their child is provided services by paraprofessionals and if so, their qualifications. During the 2016-2017 school year, 3% of the teachers at Barstow Memorial School were on emergency licenses.

<u>State Assessment Results</u> - Under the Every Student Succeeds Act, students in grades 3 – 8 and 11 are assessed annually in reading, writing and math. Science is assessed in grades 4, 8 and 11. 

FY2019 Proposed budget graphs –by function



Considerations of Budget Proposal

- Net Education Spending our taxable budget is down by 0.78% or (\$36,798)
- Equalized pupils are down by 8.43 students or 2.62%
- Result: Education Spending per Equalized pupils is up \$276 or 1.89%

State Impact on Budget Proposal

- Announced State Tax Yield is down 3.13% or \$318 per student
- Year 3 Act 46 tax incentives drops to \$0.04 (from \$0.06)- thus, \$0.02 tax increase
- Result: Proposed Homestead Tax Rate BEFORE applying CLA is up 6.85%

What is Common Level of Appraisal (CLA)? How do my property taxes change based on CLA?

The CLA is used to ensure property owners are paying equitable taxes. If the properties in a town were undervalued, without a CLA correction, the residents would pay a lower tax compared to a neighboring town with more accurate assessed values. The Tax Department determines the CLA by looking at recent sale prices and comparing these prices to the town's appraised values. If the appraised values are lower than the sale prices the town's grand list is considered undervalued and the CLA will be a percentage under 100%. Likewise, if the appraised values are higher than sale prices the town's grand list is considered overvalued and the CLA will be over 100%.


