Motion seconded by M. Smith. Discussion on the motion was conducted. S. Bridge questioned the procedure if someone disagreed with the appointment to the specific position and who makes the appointments. S. Tully clarified the motion can be amended and the Selectboard makes the motions, amendments and votes to approve the motions. Brian and Carol Gates requested Jack Kennelly not be reappointed to the Zoning Board of Adjustment. They claimed that Mr. Kennelly lied and violated their constitutional rights and that they asked for his removal from the ZBA prior to their hearing. They continued stating that Mr. Kennelly stated that the ZBA had received an appeal that was submitted timely and complete which was inaccurate because the Town had not received payment for the appeal. No further discussion was heard. The motion passed unanimously.

*Clerk and Treasurer's Report* The discussion as J. Bridge was detained assisting with technical difficulties at the Planning Commission Meeting.

Telephone Gap Project S. Tully provided a history and overview of the project. The Telephone Gap Project encompasses 72,000 acres of land between nine towns, one of which is Mendon. It is a forest and environmental rejuvenation project that spells out action plans for wildlife habitat, increased habitat diversity, soil restoration & watershed conditions, sustainable network of roads and trails, increased recreational opportunities and timber harvesting to provide wood products for local and regional economy while enhancing the forest health and diversity. The US Forest Service has issued their preliminary environmental assessment and is taking public comments. The public comment period ends April 8<sup>th</sup>. There is a map of Mendon that identifies new trails around the new forest building and a decommissioning of a trail that goes up through Blue Ridge Mountain. It also identifies new ski trails that will connect Mendon and Chittenden as well as identifies vista improvements in Mendon on hiking trails. <a href="https://www.fs.usda.gov/project/?project=60192">https://www.fs.usda.gov/project/?project=60192</a>

Rutland Regional Public Works Mutual Aid Agreement The Selectboard reviewed. Motion by M. Smith to approve the Rutland Regional Public Works Mutual Aid Agreement. Motion seconded by V. Taylor. The motion was unanimously approved.

*Grants in Aid FY25 Letter of Intent* M. Smith moved to authorize V. Taylor to submit the Letter of Intent to participate in the FY25 Grants in Aid Program. Motion seconded by S. Bridge. The motion was unanimously approved.
